**RE: REVISED - 1<sup>ST</sup> & 2<sup>ND</sup> CALL FOR NOMINATIONS – PROVINCIAL & STANDING COMMITTEES**

This is a REVISED 1<sup>st</sup> & 2<sup>nd</sup> Call for Nominations for the positions listed below, as the Public Education Director position was mistakenly missed in the original Call sent out on July 21<sup>st</sup>, 2021.

The 3<sup>rd</sup> & FINAL call for nominations will follow August 11, 2021. The elections will take place at Convention 2021.

As you are all aware, due to the pandemic, Convention 2020 was cancelled last year and as a result, elections were also cancelled. In consultation with our Union Trustees and in a practice consistent with CUPE BC and CUPE National, incumbents in positions up for election had their terms extended until Convention 2021. Of the nine positions that were scheduled for election at Convention 2020, seven of them have their terms concluded in 2021. The result is two positions that require an election at Convention 2021 for the balance of their term:

<b>Public Service Pension Plan (PSPP) Committee</b>	1 vacancy, balance of a 3-year term, ending 2023 <b>Full-time/Regular Part-time only</b>
<b>Union Trustee</b>	1 vacancy, balance of a 3-year term, ending 2023 <b>Full-time/Regular Part-time or On-call</b>

As you may recall, the initial call for nominations for the PSPP Committee position received no valid nominations. Subsequent to that, we put out an additional call for nominations with the intent to seek the special authorization of the membership at Convention 2020 in accordance with Bylaw 13.a10 to complete a by-election in accordance with Bylaw 13.d1 (see memo [here](#)). We no longer need to seek special authorization of the membership and may just proceed with the by-election at Convention 2021.

In consideration of the above, the valid nominations for the PSPP Committee and Union Trustee positions received in advance of Convention 2020 will be included on the ballot at Convention 2021. Those names can be found [here](#). The elections for these two positions will be held at Convention 2021 prior to the elections required for the positions listed below.

**PLEASE NOTE: With a change in Bylaws regarding nominations for Provincial & Standing Committee positions at the 2014 Convention, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and Final call for Nominations will now occur prior to Convention.** A list of valid nominees for each position will be published to the membership no later than 50 days before Convention. **NO FURTHER NOMINATIONS WILL BE ACCEPTED AT CONVENTION.**

**Nominees MUST CONFIRM their ACCEPTANCE of nomination ON-LINE at <http://www.apbc.ca/my-nominations> prior to the close of 3<sup>rd</sup> & FINAL call for nominations. ONLY ON-LINE acceptances will be considered valid.**

**The onus is on the NOMINEE to ensure their nomination has been accepted within the time limits. NO FURTHER attempts will be taken to confirm acceptance of nomination.**

The **DEADLINE** for 3<sup>rd</sup> & **FINAL** call for nominations is **WEDNESDAY, AUGUST 25, 2021.**
